## JONATHAN GLYDE

I Jonathan Glyde of the parish of St Thomas the Apostle in the county of Devon corn factor being by the blessing of God in sound health of mind and body do make this my last will and testament in manner & form following imprimis I give & bequeath unto my dear wife (over & above the sum of six hundred & fifty pounds which by jointure is settled upon her & her children) the sum of seven hundred & fifty pounds sterling for her own use & benefit & to be disposed of as she may think proper & I give also to my said wife the further sum of five hundred pounds for her use during her life and at her death to be divided equally amongst my son J L Glyde & my daughters Sarah Elizabeth Abigail & Melena or their children I give & bequeath to my son J L Glyde the sum of two hundred & fifty pounds I give & bequeath unto my daughter Mary Glyde the sum of one hundred & fifty pounds the smallness of this sum I trust she will not impute to any want of affection for her equal to my other children it is solely on account of her good uncle having expressed his intention of providing for her to whom & to her aunt I stand much indebted for their kindness towards her & my other children & they have my sincerest(?) thanks I give & bequeath unto my daughter Sarah the sum of six hundred & fifty pounds I give & bequeath unto my daughter Elizabeth the sum of six hundred & fifty pounds I give & bequeath unto my daughter Abigail Cayme the sum of two hundred & fifty pounds I give & bequeath unto my daughter Melena the sum of six hundred and fifty pounds I give & bequeath unto my grandson Jonathan Glyde the sum of twenty pounds I give & bequeath unto my nephew James Glyde now of Bristol the sum of ten pounds I give & bequeath unto my nephew William Glyde the sum of five pounds I further give unto my dear wife all my household goods & furniture plate linen books & including (-?) article not included in the estate(?) of Jonathan Glyde & (-?) & in case at the time of my decease I should not be in possession of the two milch cows which I have at present the value shall be made up to my said wife at the rate of ten guineas per cow & I do hereby constitute & appoint my son J L Glyde executor of this my will charging him with the payments of all the aforesaid legacies within eight months after my decease & it is my will that lawful interest for six months be paid on all the above legacies & that my executor shall pay all the duties



chargeable by law on the said legacies provided always that the effects left my me shall be sufficient for the payment of the same & all other necessary expenses & it is my will in case of any deficiency each(?) shall be reduced(?) according to their(?) sum(?) dated this 20th day of March 1809 - *Jonathan Glyde*

Proved at London 15th August 1810 before the judge by the oath of Jonathan Lavington Glyde the son & sole executor.
